- The Competition is open to students aged 18 or over currently enrolled at the participating university (the ‘University’). Students who want to enter must show an up-to-date student card for the University.

### 2. How to Enter

To enter the Competition, you must be a new or existing Bank of Ireland customer.

New customers must have completed a Bank of Ireland current account application form with our brand ambassadors or staff members. If you have not completed an application form at the University, you will need to show your confirmation email from Bank of Ireland showing that you have recently completed the application form.

Once you show that you are a new or existing Bank of Ireland customer, you can take part in the Jet, Set, Match! game (the 'Game').

Participants will need to answer a simple test of skill question before participating in the game.

- Two participants will go head to head in the Game. Participants will be given a deck of 30 cards and a country/city name, for example, France. The 30 cards will each have symbols on them. Participants must match 4 symbols from the deck of cards that are associated with that country/city name and press the buzzer provided to indicate that they are finished.
- The fastest to match the most correct symbols within the time limit of 30 seconds (as determined by Bank of Ireland's answer sheet and Bank of Ireland's brand ambassadors) will be entered into the daily prize draw to win the €500 flight voucher and will receive a spot prize.
- The runner up will receive a participation spot prize.
- In the event of a tie, a tie breaker question will be asked by the host. The first player to press the buzzer and answer the tie breaker question correctly or has the closest answer to the question will win.
- If there is any disagreement about who completed the task first, then the decision of the Bank of Ireland brand ambassador will be final as to the winner of the Game.
